The District of Columbia, Department of Human Services, Family Services Administration invites the submission of applications for funding for the provision of Youth Extended Transitional Housing (herby referred to as "Youth Extended TH"). The total amount available for the solicitation is up to \$1,785,000.00.

Purpose/Description of the Project: The District of Columbia (District), Department of Human Services (DHS), Family Services Administration (FSA), is seeking applications to provide housing and supportive services for the Youth Extended Transitional Housing program through funding for Fiscal Year (FY) 2025.

As outlined in Solid Foundations, the District's strategic plan to prevent and end youth homelessness, the District seeks to continue its investment to provide quality Extended Transitional Housing (ETH) programming. for youth ages 18 to 24. ETH is a targeted housing intervention for youth ages 18-24 that have documented mental health or disabling conditions that have substantially interfered with their ability to achieve stability and permanent housing. ETH will provide up to three years of housing integrated with a full range of supportive services including mental health, substance abuse recovery support, case management, life skills, employment services, educational services, and housing navigation services. The goal of ETH programs is that after three years of support, youth will transition to permanent housing. DHS seeks to fund up to 75 ETH beds through this solicitation with 24 of the 75 beds being dedicated to LGBTQ youth.

Length of Grant Award and Available Funding: The Grantee(s) will be awarded funding based on their capacity to meet the requirements of the program.

The award period for the grant will be from October 1, 2024, through September 30, 2025.

The amount available for the project is up to approximately \$1,785,000.00 for one base year and four option years, subject to funding availability dispersed between up to five grant awards.
